COVID-19 not detected in dental aerosols

A new study out of Ohio State University university found,

"Even when low levels of the SARS-CoV-2 virus were detected in the saliva of asymptomatic patients, the aerosols generated during their procedures showed no signs of the coronavirus."

This suggests that the risk of COVID-19 transmission during dental treatments is very low.
